

REGISTRATION: ONLINE HIGH SCHOOL BIBLE COURSE (an Elective Course)

Parents/guardians must give their written consent to the appropriate school by completing this form and forwarding it by fax or mail to the person designated below. The courses are offered virtually. There is no cost to enroll in the course, including needed software. Students are responsible for providing their own device and internet access. A personal student email address will be required and forwarded to the distance learning provider for the student's course set up by **Christian Learning Centers of Greenville County (CLC)**, the entity offering the Released-Time Christian Education online Bible course.

The requirements for participation are as follows:

- The student registration window for CLC online courses offered next school term is January through March of the current year. Enrollments must be approved by the school counselor.
- After approval, all student work must be completed in a timely manner.
- Parents will receive progress updates regularly throughout the semester. Parents are encouraged to monitor their student's progress to make sure all assignments are completed on time.
- The parents/guardians understand that no public funds are expended, and no school personnel members are involved with providing the instruction.
- Students may be required to attend at least five site events and participate in a service-learning project.
- Up to two Carnegie units of credit can be awarded toward the requirements for the receipt of a South Carolina high school diploma. One credit can be earned for completing Bible 101 and one credit for completing Bible 102.
- The course will be graded as a pass/fail course and will not be counted in the student's GPA.
